GFI Policy Statement

Use of Paper

- We aim to make sure that , wherever possible, all paper, board and packaging used meets our stringent environmental specifications and as a minimum these materials are ECF or TCF Elementally or Totally Chlorine Free which is the kindest way to bleach the pulp.
- We actively encourage and promote the use of FSC Certified Paper, 100% Recycled Paper or paper containing an element of recycled fibre.
- Our website products, business cards and leaflets are printed on FSC Papers or 100% Recycled Paper or card.

Reducing or Avoiding the use of Chemicals

- We use an inert water based corrector
- We use biodegradable cleaning materials

Reducing and Recycling Waste

- We will continue to seek ways to reduce waste.
- We segregate, re-use and recycle the waste unavoidably produced in the course of our work.
- We invest in IT equipment which is more efficient and less wasteful of materials in the first place.

Energy Consumption

- Equipment is chosen to be more efficient faster setup and running speeds ensure more output per Kw of electricity used.
- We use a green energy supplier

Green Office at GFI

- We print double sided in the office where possible.
- We print in black and white
- All light bulbs used are of the energy saving type.

GFI Environmental Policy/PB

- We switch off lights when they are not needed.
- Computers and monitors are turned off when not in use.
- Where possible our toner cartridges are recycled
- Our Company Stationery is printed on Recycled Paper and marketing materials including our own full colour Leaflets are printed on recycled or FSC Certified Paper.
- We use Business Cards printed on recycled card and display the FSC 100% recycled logo on the reverse.
- Office waste paper is segregated and collected for recycling along with our production waste paper.
- Online selling rather than reliance on a sales force reduces energy and resources consumption dramatically.
- Our tea bags and coffee are from fair trade sources.
- We use email where possible to communicate rather than fax or letter.
- We do not print documents unless absolutely necessary.
- We use video conferencing where it is feasible and sensible.
- We try not to use plastic or paper cups.
- We sponsor or support local environmental initiatives.
- We are signed up to our local authority or business enterprise scheme for recycling, re-using and efficiency.
- We have appointed a member of staff who is enthusiastic about green issues as the company "green champion".
- We will encourage further environmental improvements
